THEY RECEIVED OVER 1.3 MILLION POUNDS OF PRODUCT THAT THEY IN TURN DISTRIBUTE OUT INTO THE COMMUNITY TO HELP MEET THE NEEDS OF CLIENTS THEY ARE WORKING TO HELP BETTER THEIR LIVING CONDITIONS.
